2. Scope

This MOU sets forth the intentions of the Parties for increased collaboration, cooperation and interaction and does not create any legally binding commitments. MoU: Memorandum of Understanding VIRTUAL RESOURCES EXCHANGE PROGRAM (VREP)

This agreement is made between the **Department of Mass Communication and Journalism at Pazhassiraja College Pulpally**, a government-aided institution of higher education affiliated to the University of Calicut which is located at Pulpally, Wayanad District, Kerala State, India, 673579 (hereinafter Party 1) and **Faculty of Mass Communication, Ahran Canadian University** located at Giza, Al Jizah, Egypt (hereinafter Party 2).

In the spirit of friendship and with a mutual interest in cooperation, The Department of Mass Communication and Journalism, Pazhassiraja College, and the Ahran Canadian University, Giza, Al Jizah, Egypt enter into this virtual Memorandum of Understanding (MoU) to promote joint media educational and cultural collaboration and agree as follows:

I. SCOPE OF VIRTUAL COLLABORATION

Areas of collaboration may be proposed by either institution and may include, but are not limited to:

- a. Short-term online certificate programs
- b. Online- Joint teaching, research, or cultural activity;
- c. Mobility of faculty, scholars, and students between institutions; (if applicable)
- d. Staff professional development
- e. Sharing or creation of educational materials and resources.



Any specific activity developed under this MOU shall be detailed in a subsequent agreement, signed by each institution's authorized signatory (Virtual documentation), which will describe the scope of the proposed activity, intended outcomes, and responsible departments or individuals.

II. DURATION AND EVALUATION

1. This MOU shall be in effect for a period of 2 (Two) years from the last date of signature.
2. Either party may request termination of this agreement, in writing, ninety (90) days prior to the proposed termination date.
3. Any activities in progress at the time of termination shall be permitted to conclude as planned unless otherwise agreed in writing.
4. A joint evaluation of the MOU will be initiated by the designated representatives six (6) months prior to the expiration date.
5. Following the evaluation, the MOU may be renewed and resigned for an additional five (5) year period.
6. Amendments to this MOU may be requested, in writing, by either party and approved by the authorized signatories.

III. NON-DISCRIMINATION

The parties agree not to discriminate on the basis of religion, race, creed, national or ethnic origin, sex, age, handicap, political affiliation, sexual orientation, disability, or status as a veteran.

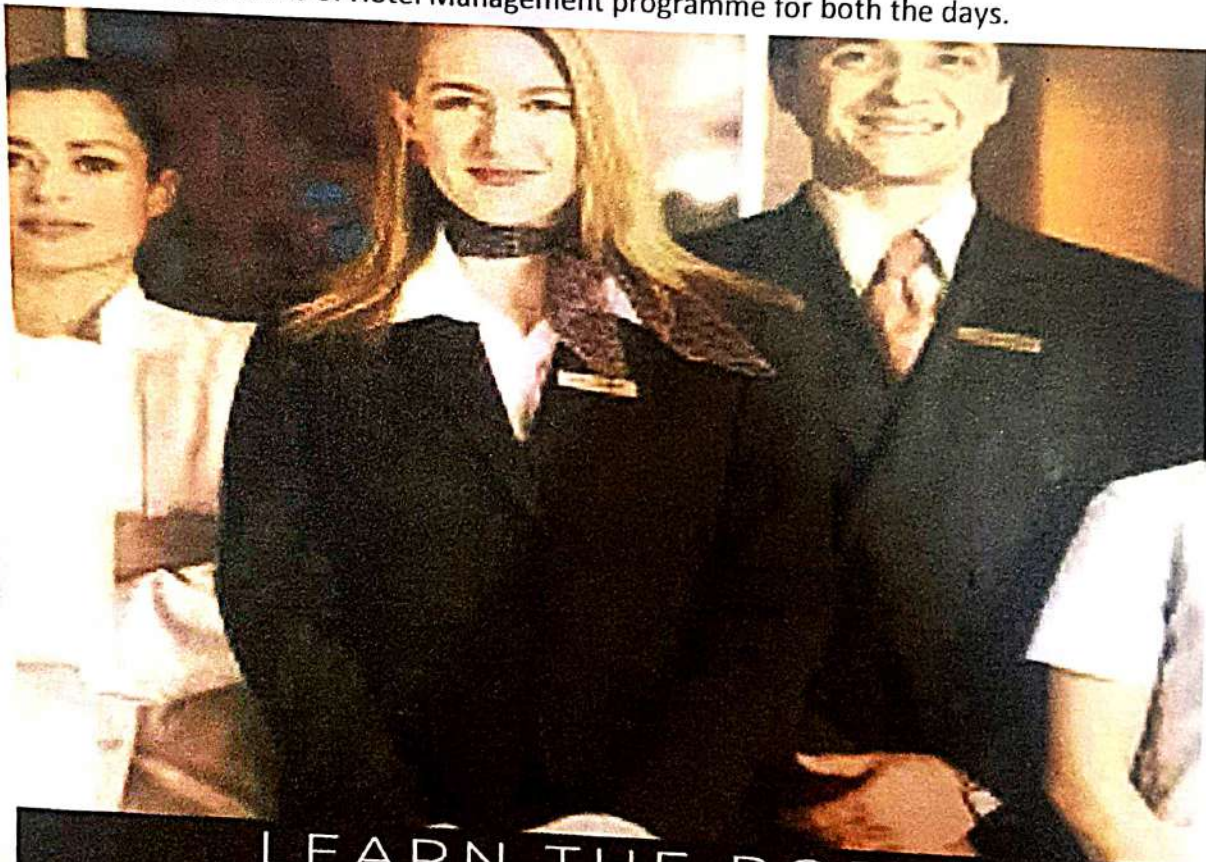


FACULTY AND STUDENT EXCHANGE PROGRAMME
